



Firepit Sweepstakes | Terms & Conditions

GRAND PRIZE: (1) Handmade Firepit

Potential winners will be required to sign and return a sworn Affidavit of Eligibility and Liability and Publicity Release. If required documentation is not returned within four (4) business days of notification, or if notification is returned as undeliverable, any prize will be forfeited and an alternate winner will be selected by random drawing.
